

Terms and Conditions

Rental – Extension

The rental prices and amount of deposit are determined in accordance with the applicable tariffs and payable in advance. Deposits can't finance rental extensions under any circumstances.

Vehicle's usage

The renter agrees not to allow the vehicle to be driven except by the authorized drivers on roads intended for automobiles (off road forbidden), on the European territory only, without taking part in any competitions, rallies, or automobile races or tests. All use, other than those mentioned in the « terms and conditions » will lead demand of damages.

Regulation and requirements

By the time of Bike pick up, the renter and the authorized driver(s) are solely responsible for the payment of all parking fines, speeding tickets, and any other legal contraventions or verbal processes during the hire period, according to the « article 21 de l'ordonnance 58 - 1216 du 15 décembre 1958".

25 years of age or older / 3 year minimum valid driving motorcycle license

Vehicle condition

When picking up the motorcycle, the renter acknowledges that the vehicle is in good roadworthy condition. The renter will not be able to claim any compensation for service interruption, incident or accident applied to any malfunction of the vehicle nor to be relieved of the renter's obligations. The renter acknowledges that the vehicle is rented with its full equipment which must be returned in good condition otherwise the renter will have to pay at its replacement value. **Any alteration or transformation of the vehicle is strictly prohibited.**

Insurance - Deposit

From the moment the vehicle is handed over to the lessee, the latter becomes vis-à-vis third parties the sole custodian responsible under the terms of article 1384 of the Civil Code. However, subject to formal condition that the vehicle will be driven by the lessee or the approved driver, the lessee will be guaranteed. In the event of a responsible accident (with or without a third party), the recourse exercised by the lessor against the lessee may not exceed the amount of the deposit (3,800 euros CAT GT +; 3,200 CAT GT; 2,500 euros CAT T / OS, 1,000 euros for scooter 125 and 450 euros for 50cc scooter) paid by the tenant.

The insurances are only in force for the duration of the stipulated rental. If the lessee keeps the vehicle for longer without having rectified his situation under the conditions provided for in the *Rental - extension* paragraph, he loses the benefit of all the guarantees provided for in the contract.

The deposit paid by the tenant will not be canceled until 30 days after the return of the vehicle (maximum time to receive any notices of violation of the French or foreign highway code). **Each ticket received related to a traffic violation will be subject to an additional charge of 45 euros for administrative fees in addition to the amount of the fine.**

Returning rental vehicle

The rental vehicle, sole property of the bike agent, must be returned by the renter themselves or at their own expense at the rental office during working days. The renter acknowledges that, at the expiration of the rental period and except in case of rental extension, the bike agent will be able to repossess, as of right and without any judicial formality, the rental vehicle, under the control of any person and will be subject to claim for damages for the loss due. The renter shall not abandon the vehicle without prior written consent of the bike agent. If the vehicle repatriation shall be impossible, it will be done at the own expense of the renter, the extra cost of the rental will obviously be charged to the renter. In case of no return within 48 hours, prosecutions will be initiated. The vehicle is provided with full tank and shall be returned with full tank (except within the option of « Full Tank ») otherwise the renter will be charged 2.60€ per missing liter.

Terms of cancelation

Full retention of the deposit (30% of the total rental amount).

Conditions for changing dates

More than 60 days before the date of taking charge of the vehicle: 100 euros administration fees if the new dates are in the same year.

Less than 60 days before: 250 euros administration fees if the new dates are in the same year.

SECURITY DEPOSIT – DEDUCTIBLE

The initial deposit (3800 euros CAT GT +; 3200 CAT GT; 2500 euros CAT T / OS, 1000 euros for 125cc scooters, 450 euros for 50cc scooters) corresponds to the excess in the event of theft, damage or responsible accident (with or without an identified third party).

On the day the vehicle is taken over, a “deductible buyback” insurance is offered to the lessee of the vehicle under the following conditions:

VIP 50 % = deductible at 50% of the amount of the initial deductible.

The reduced deductible is only applicable in the event of an accident wrongly or without an identified third party. The theft deductible remains the initial deductible.

In the event of an accident or damage to the rented vehicle, the excess is returned to the renter only after the insurance (Mutuelle des Motards) is recognized as 100% non-liability of the designated driver.

TIRE TIRE WARRANTY

The cost (s) of repair or change of flat tire (s) during the rental period of the vehicle are the responsibility of the tenant.

On the day of taking charge of the vehicle, the “PNEU CREVE” guarantee is offered to the renter of the vehicle under the following conditions: Cover by the lessor of the costs of repairing or changing a flat tire during the rental period.
